**DECLARATION OF SUE RUDD**

The Declarant, SUE RUDD, states the following:

1. My name is Sue Rudd and I am over the age of 18 years.
2. During the pendency of the case involving the death of Lisa McPherson, I was the judicial assistant for the Honorable Susan Schaeffer. While the civil case was pending before Judge Schaeffer, to my surprise, David Miscavige, head of the Church of Scientology, appeared at my office at the courthouse located in St. Petersburg, Florida, and requested to see Judge Schaeffer.
3. I immediately informed Mr. Miscavige that Judge Schaeffer was not in her office, she was in Tallahassee, attending a legislative function. I further advised Mr. Miscavige that it would be improper for him to meet with Judge Schaeffer without the presence of opposing counsel.

4. Mr. Miscavige remained in my office and we engaged in conversation. After a short period of time, I proceeded to leave my office to go outside. Mr. Miscavige left with me and joined me outside where we continued to engage in conversation. At no time was the Lisa McPherson case mentioned, he did talk about Scientology.
5. I may supplement this Declaration upon further reflection if I remember more details of what Mr. Miscavige said.

I declare under penalties of perjury of the laws of the State of Florida that the foregoing is true and correct.
